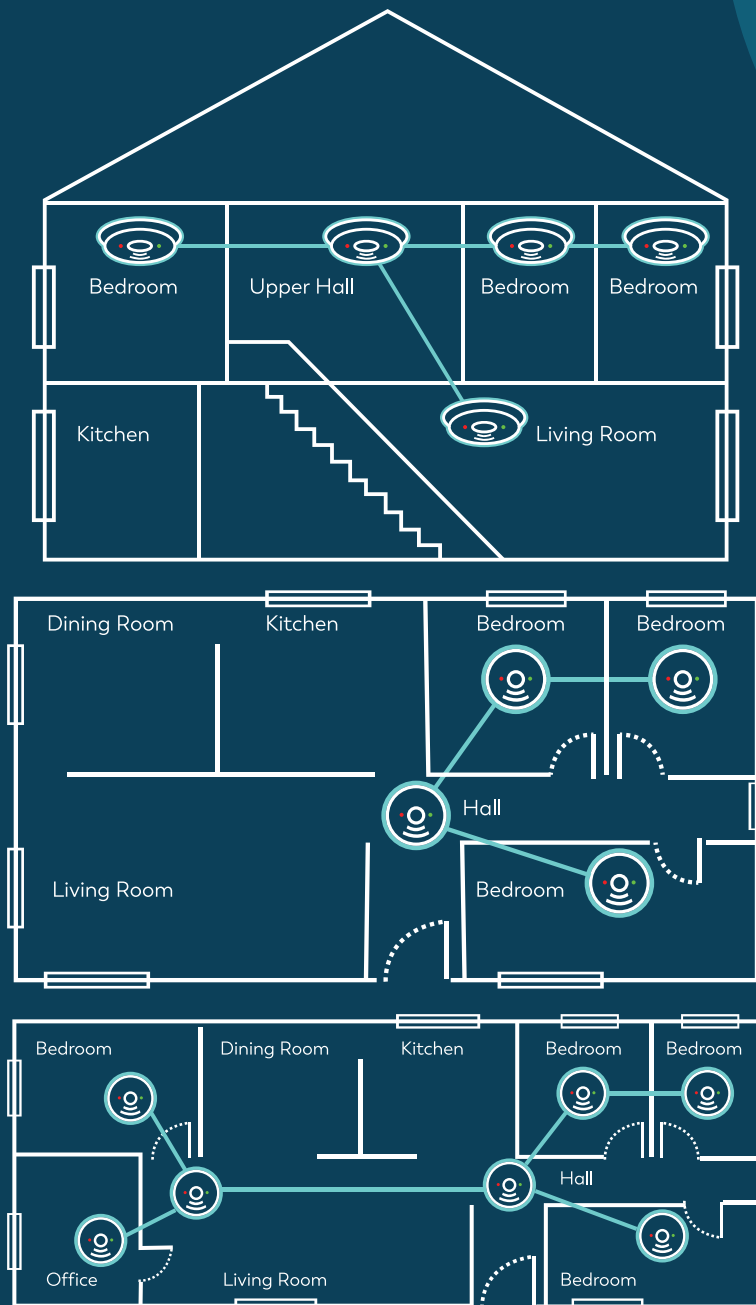

If alarms are missing or broken at the time of inspection, then a cost for replacement alarm will be charged. If re-attendance to a property is required to rectify missing or broken alarms a call out fee will apply plus the cost of the replacement alarm.

# WHAT ARE UPGRADED SMOKE ALARMS?

Upgrading your home's smoke alarms will increase your family's protection should there be a fire in your home. Interconnected alarms and alarms in bedrooms ensure everyone is alerted to a fire, even if they are asleep in bedrooms with doors closed, giving you and your family more time to escape safely.



**Upgraded means that your home meets the latest requirements of the Fire and Emergency Services (Domestic Smoke Alarms) Amendment Bill 2016. According to the new law, by 2027 smoke alarms in all dwellings must:**

- Be photoelectric and less than 10 years old.
- Meet the new Australian Standards (AS 3786:2014).
- Be interconnected with every other smoke alarm in the property so all activate at the same time.
- Be hard-wired or wireless alarms powered by a non-removable 10 year lithium battery or a combination of both.

## **AND**

- Be installed on each storey.
- Be installed in each bedroom.

## **AND**

- In hallways which connect bedrooms and the rest of the property.

## **OR**

- If there is no hallway, between the bedrooms and other parts of the storey.
